

# LIGHT AND BRILLIANCE

## MEMBERSHIP AGREEMENT

**ELIGIBILITY CRITERIA:** A person who presents interest in becoming a public member of the Light and Brilliance Organization shall meet the requirements as listed in the organization's bylaws as stipulated in ARTICLE V (5).

After careful evaluation of the documents and by majority vote from the Board of Directors, membership shall be granted to an individual who meets the following requirements and exhibits the following interests. The organization shall subsequently provide an orientation process to all new members no later than 2 weeks after inscription.

### Section 5.1 Eligibility for Membership

Public membership shall be open to any person who has profess their faith in Jesus Christ publicly, is in good standings with the church they belong to, is free of any legal bind, is able to fulfill a position of respect to the governing body of this organization and abides by and supports the bylaws as well as the organization's purpose, mission and vision.

A person interested in becoming a member of this organization shall meet the following requirements:

- a. The prospect shall file an application.
- b. Present a letter of intent stipulating the reasons he/she shall be considered.
- c. Must provide personal identity information, demographics and legal citizenship status.
- d. Present a letter of recommendation from their Pastor or spiritual leader.
- e. A member shall be responsible to protect the integrity of the organization.
- f. Shall watch with careful reverence the well-being of the organization.

- g. Shall understand he/she is not an employee, contractor, or constituent of the organization.
- h. Shall not use the Light and Brilliance Organization's name for any personal dealings, representations or financial gain.
- i. Shall not use any of the copyright materials to reproduce, sell or use without written consent by the organization's Board of Directors.
- j. Shall be willing to give back if their heart is touched to share of what God has given to them in order to offer support to the organization; material or financial to help others. **This is not mandatory.**
- k. Shall honor Jesus Christ with their personal testimony.

### **Section 5.2 Membership Responsibilities**

An active member shall assume the following responsibilities:

- a. Actively participate in meetings and events regularly (at least three meetings and/or events per semester).
- b. Provide clear and timely communication in response to meeting and/or event invitations.
- c. Volunteer, when available, at community service events or organizational activities.
- d. Maintain professional conduct by treating fellow members and our guests with respect and courtesy.
- e. Help maintain a positive, friendly environment necessary for all members to learn and grow.
- f. Be an ambassador for Jesus representing Light and Brilliance Organization and an advocate to recruit new members for the organization.

### Section 5.3 Membership Benefits

These shall include:

- a. New member reception and welcoming package.
- b. Membership announcement in the Light and Brilliance's newsletter and on its website.
- c. Monthly newsletter.
- d. Opportunities to connect with fellow members, committee members and officials.
- e. Opportunities to attend any of the workshops/conferences at no additional cost for professional development, leadership roles, spiritual enrichment and community service.
- f. Access to health-psychological educational resources on local, national, and international levels.
- g. Receive information on new research studies as these become available.
- h. Invitation to the annual assembly with voting privileges to elect the Board of Directors appointees.
- i. Invitation to local, regional, and national health and Christian conferences.

### Section 5.4 Membership Donations

**Membership is not mandatory.** Members are not required to offer any monetary, physical or material support. However, accepted members can make a donation if they desire to help the program's overhead cost and to help others. Anyone willing to give back if their heart is touched to share of what God has given to them in order to offer support the organization; material, financial or physical volunteer work to help others. Thus becoming agents of change to help others in their process. This ministry is supported by individuals who are grateful for the blessing they have received here. Members donations are greatly appreciated.

The secretary of the organization will maintain all records for each member and shall notify each member in writing of their contributions. **Each member has the right to cancel his/her membership at any time.**

**Section 5.5 Rights and duties of Members**

Members have no legal bind to the organization, are not employees, contractors or paid prospects of the organization. **Each member has the right to cancel membership at any time.** Each member shall be eligible to cast a vote in the organization's general Board of Director's election, shall participate in all the organization's meetings, activities, worship, teachings and free programs.
